1. Chairman Nordengren called the meeting to order at 11:35 a.m. Roll call showed that a quorum was present.
2. A motion was made by Ms. Salato and seconded by Mr. Siedentop to accept the letter of resignation from Lou Naretto with regret. Motion passed on 4-0 vote.

7. A motion was made by Ms. Salato and seconded by Mr. Nordengren to name Jeff Hanford as a new trustee. Motion passed on a 4-0 vote.
